

# **All Stars – All Star Moments**

## **Competition Terms & Conditions**

### **1. Promoter**

1.1 The promoter of this competition is All Stars (“the Promoter”).

1.2 The competition is operated via the All-Stars website and associated All Star Moments social media channels.

### **2. Eligibility**

2.1 The competition is open to UK and Republic of Ireland grassroots football teams only.

2.2 All entries must be from a grassroots football setting involving Under 18s (U18) teams.

2.3 Professional academies, elite development programmes, and semi-professional environments are excluded.

2.4 Entries are open to both boys’ and girls’ teams, where applicable.

### **3. Acceptance of Permissions & Responsibility**

3.1 By submitting a video entry, the entrant confirms they have obtained all necessary permissions and consents from:

- Players
- Coaches
- Clubs
- Parents or legal guardians (where participants are under 18)

3.2 The entrant accepts full responsibility for the sharing, publication, and use of the submitted video.

3.3 All Stars accepts no liability for disputes relating to permissions, consent, or ownership of submitted content.

### **4. Parent / Guardian Declaration**

4.1 Where a submitted video includes participants under the age of 18, the entrant confirms that informed consent has been obtained from a parent or legal guardian for:

- The recording of the footage
- Submission to the All-Star Moments competition
- Public use of the footage across All Stars digital platforms, including social media and YouTube

4.2 By submitting an entry involving minors, the entrant declares they are authorised to provide this consent on behalf of the parent or legal guardian and accepts full responsibility for the accuracy of this declaration.

4.3 All Stars reserves the right to request proof of consent were deemed necessary.

## **5. Entry Requirements**

5.1 All submitted goals or moments must have occurred during the calendar month to which the competition relates.

5.2 Entries must be submitted no later than the 14th day of the following month to be considered.

5.3 Submissions must be completed exclusively via the All-Stars website using the official submission form.

5.4 All required fields on the submission form must be completed for an entry to be valid.

5.5 Each video submission must be:

- A minimum of 10 seconds in length
- A maximum of 15 seconds in length

Entries that do not meet these requirements will be deemed void.

## **6. Number of Entries & Shortlisting**

6.1 Teams may submit multiple moments per month.

6.2 Each submitted moment will be treated as a separate entry.

6.3 A team may only win once per competition month, regardless of the number of entries submitted.

6.4 A maximum of eight (8) submissions per month will be shortlisted per competition category by the All-Stars Selection Committee.

6.5 The Selection Committee's decision is final, and no correspondence will be entered into regarding shortlisting decisions.

## **7. Voting & Judging**

7.1 Shortlisted entries will be published across All Stars platforms for public viewing and voting.

7.2 Voting methods and weighting will be determined by All Stars and may include:

- Panel or committee assessment
- Public voting

7.3 Any attempt to manipulate, influence, or unfairly affect voting may result in disqualification.

## **8. Prizes**

8.1 The initial prize fund includes:

- £50 paid to the winning grassroots team
- A player gift reward pack for the player(s) involved

8.2 Prize funds are subject to change; however, a minimum prize of £50 per competition category introduced will be awarded unless otherwise stated by the Promoter.

8.3 All Star Moments is a monetised social media programme, and financial income generated in the previous month will determine the prize fund for the following month.

8.4 Prizes are non-transferable and no cash alternative will be offered unless stated.

## **9. Use of Submitted Content**

9.1 By entering the competition, participants grant All Stars a royalty-free, perpetual, and irrevocable licence to use, edit, reproduce, distribute, and publish submitted videos for:

- Competition purposes
- Social media and digital platforms
- Website content
- Promotional and educational materials

9.2 All past entries and voting videos will be archived on a public YouTube channel operated by All Stars.

## **10. Purpose of the Competition**

10.1 The All-Star Moments competition exists to:

- Increase the public profile of All Stars
- Celebrate the fantastic work delivered by grassroots clubs and coaches
- Support the All-Stars grassroots football programme
- Provide coach and player education using real grassroots moments

## **11. Disqualification & Void Entries**

11.1 Entries that do not meet these Terms & Conditions will be deemed void.

11.2 If a winning entry is later found to be invalid, the prize will automatically be awarded to the next eligible placed entry.

11.3 All Stars reserves the right to remove content or disqualify entries at any stage.

## **12. Expansion of the Competition**

12.1 Subject to the success of All Star Moments, All Stars may expand the competition into additional categories, including but not limited to:

- Foundation Phase (5v5 & 7v7)
- Youth Development Phase (9v9 & 11v11 – U12s to U17s)
- Youth Transition Phase (U16s to U18s)

12.2 Competitions may operate across both boys' and girls' categories.

## **13. General**

13.1 All Stars reserves the right to amend these Terms & Conditions at any time.

13.2 Participation in the competition constitutes full acceptance of these Terms & Conditions.

13.3 This competition is governed by and construed in accordance with the laws applicable within the United Kingdom.
